10		Mr. Gnadt reviewed October statistics. While ridership was down 74.7% from last year, MTD
11		is still carrying over 340,000 passengers in October. Staff continues to work diligently to keep
12		operating expenses down.

14		The Illinois Department of Transportation (IDOT) awarded MTD a \$7,597,500 Rebuild Illinois
15		grant that will be allocated to the following projects: \$2.9M to purchase three 60' hybrid buses

17		construct a solar array that will power the hydrogen production station. Due to pandemic cuts,
18		the University will have to reduce their campus bus service by 39.2% starting in January 2021.

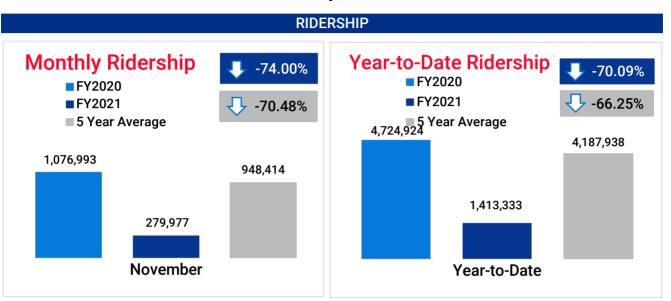

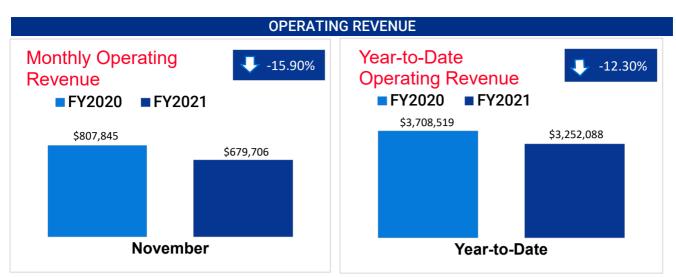
There were 279,977 rides in *November 2020* – 19% less than *October 2020* and 74% less than *November 2019*. November daily ridership mirrored October's until the UI Fall break on the 21st. Ridership on SafeRides was higher before the break than it was in October (85/day vs 60/day), but then took a nosedive during the break. As such, total SafeRides ridership was about the same for both months (~1,800).

Pre-break, there were an average 12,700 daily rides on weekdays, 8,400 on Saturdays, and 5,200 on Sundays. During the break, averages were 8,200 daily rides on weekdays; 5,200 on Saturdays; and 2,800 on Sundays.

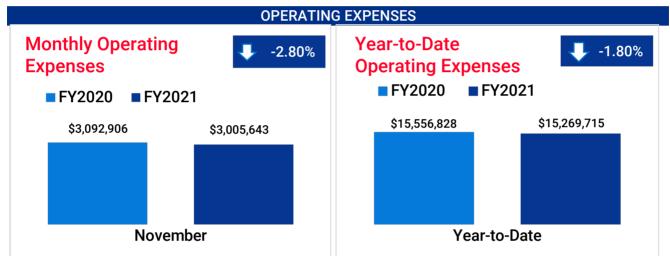
• November weekdays had the most daily ridership on the Yellow (1,000 riders), Green (975), and Illini (915), followed closely by the Grey (830) and Red (800). The Illini evening (360 nightly rides) outpaced the Yellow (270) and Grey (240) evening routes.

• Saturdays' most popular routes were the Grey (1,130 daily rides), Green (1,100) and Yellow (1,050). Other routes provided 350-400 daily rides, except for the Ruby (160), Lime (150) and Illini Limited (125). The Illini dominated in the evening, however, with 310 nightly rides—closely followed by the Evening Yellow at 300 daily rides. All late night routes provided fewer than 10 trips per night because service ended at 1A.

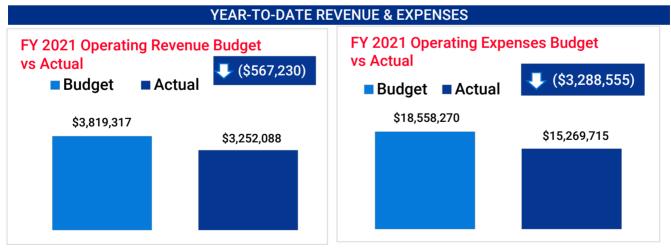
• Sunday daily ridership was heaviest on the Yellow (700), Grey (590) and Green (570). The Teal, Silver and Lavender each provided around 200 daily rides, leaving the Illini Limited (120), Ruby (80) and Lime (60) in last place. In the evening, the Illini carried 160 daily passengers, followed by the Late Night Yellow, Late Night Teal and Silver Evening each at about 60 daily riders. The Green Late Night provided around 40 daily rides.



November, 2020 operating revenue was 15.90% below November, 2019, and year-to-date operating revenue was 12.30% below FY2020.



November operating expenses were 2.80% below November, 2019. Year-to-date operating expenses were 1.80% below FY2020.



Year-to-date operating revenues are \$567,230 below budget while operating expenses are \$3,288,555 under budget.

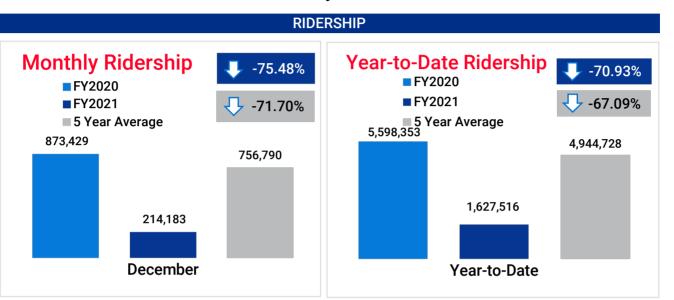

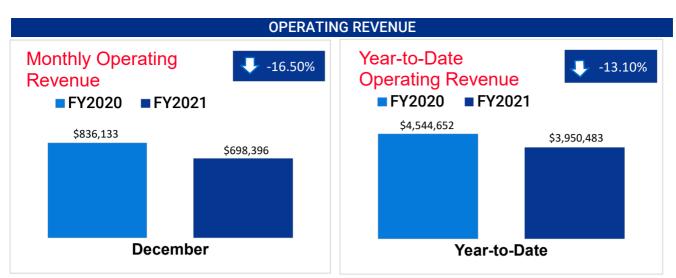
There were 214,183 rides in December 2020–31% less than November 2020 and 87% less than December 2019. Ridership fell further this year because the UI winter break lasted all of December. SafeRides dropped from approximately 1,800 rides in November to around 400 rides in December, again, because most students were not in town for the month. West Connect ridership slightly increased from previous months' 3/day to 4/day in December, perhaps due to holiday shopping or poor weather.

Because of December's Non-UI service, most ridership was on community routes. There were 8,600 rides on the average weekday before Christmas eve. This fell to an average 6,000 per day from Christmas to the 31st.

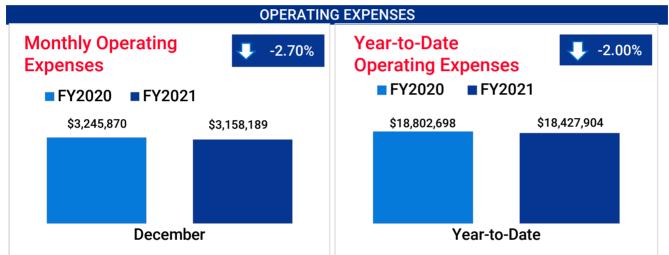
• Weekdays averaged 7,300 rides during the day, 970 at night. Daytime Yellow (950/weekday), Green (830) and Grey (750) had the highest ridership this month. The Red (701), Greenhopper (587), Lavender (513) and Orange (503) also had relatively decent ridership. In the evening, the Yellow (240), Grey (230) and Green (190) provided the most nightly rides.

• Daily Saturday ridership (4,400 day, 920 night) was higher on the Grey (1,040/day) and Green (910) than during weekdays. The Yellow (930) also performed strongly. At night, the Yellow (255) led the Green and Grey (200), with the Green Hopper trailing (100).

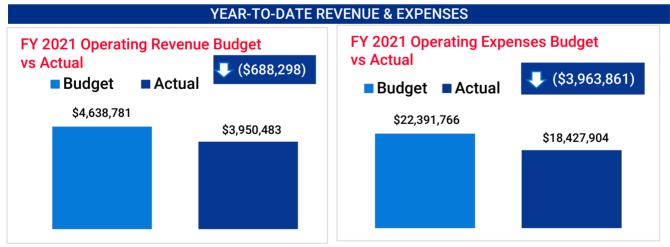
• Sunday ridership (2,900) followed a similar pattern to Saturday with 804 daily rides on the Yellow, 680 on the Grey and 670 on the Green. There was no nighttime service on Sundays because of the UI break.



December, 2020 operating revenue was 16.50% below December, 2019, and year-to-date operating revenue was 13.10% below FY2020.



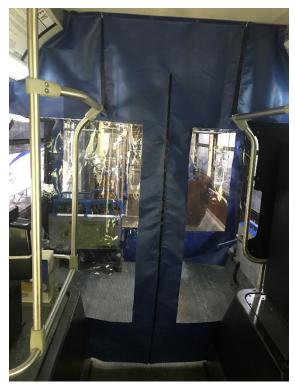
December operating expenses were 2.70% below December, 2019. Year-to-date operating expenses were 2.00% below FY2020.



Year-to-date operating revenues are \$688,298 below budget while operating expenses are \$3,963,861 under budget.

MANAGING DIRECTOR'S NOTES

The UI has asked us to help transport COVID-19 positive and COVID-19 close contact students to isolation and quarantine locations at the beginning of the semester. They currently offer an on-demand service, but it can't handle the larger expected volume that comes when the students come back to campus from Winter Break. The new route consists of two buses, one for COVID positive students and one for close contacts who need to be in isolation or quarantine from about 8A – 7P, seven days a week. The route is designed to loop around campus to pick up students at designated stops from dorms, private residence halls, some off-campus high-density residential areas, and some testing locations. Then the bus will continue off-campus to serve the destination hotel, the Comfort Inn on north Lincoln. We have outfitted three 2001 articulated buses with plastic barriers (pictured below) to help protect the Operator, who will be outfitted with an N95 mask/respirator to be worn the entire time. This service may run temporarily during the expected high demand period for at least the first few weeks of the semester and will be evaluated regularly until the demand has diminished.



The front plastic barrier as seen from the front of the bus looking back. A zipper will make it possible for the operator to load passengers using wheelchairs into the securement area.



The rear plastic barrier as seen from the middle door looking toward the front of the bus. The clear plastic "window" will allow the operator to see into the passenger compartment. All ambulatory passengers will load from the rear two doors.

Our new hiring campaign is on our fleet, on local radio stations, and soon to be featured across social media (including Facebook, Instagram, YouTube, and Spotify). This campaign features our employees alongside the benefits of working at MTD. Examples pictured on the following page:



Human Resources continues to track COVID-19 data within MTD and noticed some improvements in December's data. Although we experienced our largest number of positive cases last month, the number of Close Contacts and Brief Contacts exposed to these positives diminished significantly, resulting in about a 60% reduction of exposure cases from the month before. We believe we can associate some of these improvements with our new mask requirements and stronger messaging about keeping 6' distances from each other. In all, December's new cases bring our total number of COVID cases to 27, which represents about 7.5% of our workforce.

Just an FYI and another blow to the budget: most forecasts are indicating that interest rates will continue to be close to or at zero for the foreseeable future. This is mostly continued fallout from COVID-19 and the greater need for borrowing money to keep lives and businesses afloat. Of course, the downside is that we won't be making much interest off the money in the bank. But ... needs are great.

Over the past year Maintenance has had several new technicians start. Low seniority employees often times find themselves mostly working nights. There is no such thing as a transit bus maintenance school, so coming into any transit agency is a big learning curve as a mechanic. Thankfully, we have a highly skilled group of high seniority technicians as teachers. For example, Tom Franks (a 19-year MTD veteran) has been working the night shift for the past few weeks in order to teach our most recent hires. The day shift crew has been leaving select jobs for the night crew to work on together. Everyone sharing knowledge and helping each other builds teamwork and increases the quality of work happening in the shop.

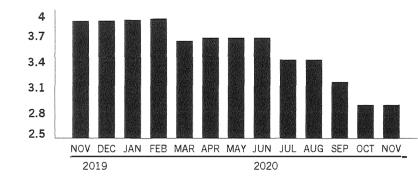

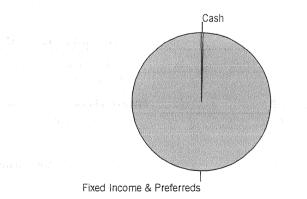

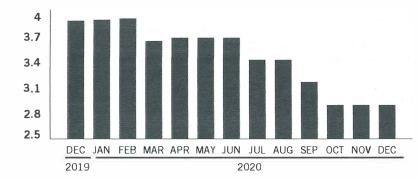

The below chart displays the most recent thirteen months of Market Value.

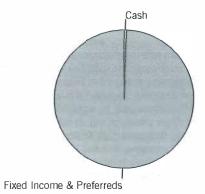

Subject: Approval of Bus Procurement Contract & Purchase

- **A.** Introduction: The District's current five-year bus procurement contract expires in March 2021. In the next five years, over half of the District's fleet of 114 buses will exceed the Federally defined useful life of 12 years.
- **B. Recommended Action**: Staff recommends authorization of the Managing Director to enter into a five-year bus procurement contract with New Flyer of America, Inc. and to issue a purchase order for five 40-foot hybrid buses, pending IDOT concurrence.
- **C. Summary:** The District is participating in a joint bus procurement with four other transit agencies. In this type of procurement, proposers submit bids for the base cost of the bus and each agency customizes the vehicle after the award is made (for example: paint scheme, seats, flooring, CAD/AVL, etc.). New Flyer's bid for the base cost of the bus is provided below. We have provided an estimate of the final cost of the 40-foot bus after the District's customization is complete.

New Flyer Price proposal base bus cost: 40-Foot Diesel-Electric Hybrid: \$581,935

60-Foot Diesel-Electric Hybrid: \$923,899

Estimated cost of first order of five 40-foot hybrid buses: \$3,400,000 (\$680,000 per bus).

Executing a contract with New Flyer commits the District to purchasing a minimum of 30 hybrid buses with the option of purchasing 29 additional hybrid buses within five years.

D. Background: A Request for Proposals (RFP) for this joint procurement was released on October 1, 2020 and proposals were received on December 9, 2020. We received three proposals which were evaluated based on established criteria. More detail on the evaluation process can be found in Exhibit A. A price analysis determined New Flyer's bid to be fair and reasonable (Exhibit B).

E. Alternatives – advantages/disadvantages

- 1. A five-year contract for bus procurement allows the District to replace aged buses with high mileage.
- 2. Lack of an agreement for bus procurement results in the inability to maintain a state of good repair.
- **F. Budget & Staffing Impacts:** Funding for upcoming bus procurements will come from multiple sources. We anticipate utilizing 80% (~\$2,720,000) Federal funding and 20% (~\$680,000) local funding for the initial purchase of five 40-foot diesel-electric hybrid buses. A combination of federal, state, and local funds will be used for the additional buses purchased on the five-year contract.

Based on the evaluation, the Committee recommends award to New Flyer Industries for all 35, 40 and 60-foot buses and to Gillig for the 30-foot CNG buses as New Flyer does not build this type of bus.

New Flyer submitted a strong proposal with fair and reasonable pricing. It is evident that New Flyer will be able to provide quality buses that fit the agencies' needs in the requested timeframe. The proposal included three references for New Flyer, each of which were contacted. All three references spoke positively about their experiences working with New Flyer.

A price analysis has been completed, attached here, determining New Flyer's bid for hybrid buses to be fair and reasonable.

- **A.** Introduction The District will utilize State grant funding for the purchase of hybrid buses to replace three 20-year-old standard diesel buses in MTD's fleet.
- **B.** Recommended Action: Staff recommends authorization of the Managing Director to issue a purchase order in the amount of \$3,010,271 for three 60-foot diesel electric hybrid buses, pending IDOT concurrence.
- **C. Prior Trustee Action:** On September 30, 2015, the Board of Trustees provided approval to enter into a five-year bus procurement contract with New Flyer of America.
- **D. Summary:** MTD's current contract with New Flyer gives the District the ability to purchase 40-foot and 60-foot diesel-electric hybrid buses through March 2021. Staff requests approval to exercise options on the contract by issuing a purchase order to New Flyer for three 60-foot diesel electric hybrid buses. The buses are \$1,003,423.64 each, totaling \$3,010,270 for three buses.
- **E. Background:** When entering into the contract with New Flyer in 2015, the District operated 33 40foot standard diesel buses built in 2003 with over 500,000 miles and 12 60-foot standard diesel buses built in 2001. Today, we continue to operate nine 60-foot standard diesel buses. The federally defined useful life of a bus is 12 years or 500,000 miles. The table below shows the purchases that have occurred since that time. Row #8 indicates the purchase associated with this request.

F. Alternatives – advantages/disadvantages

- 1. Authorizing the Managing Director to issue a purchase order allows replacement of aged buses.
- 2. Not authorizing the Managing Director to issue a purchase order would result in the inability to replace 20-year-old buses.
