4. Public Hearing on General Tax Levy Ordinance for 2021

Mr. Diel asked public input on the General Tax Levy Ordinance of the Champaign-Urbana Mass Transit District for revenue year 2021 to be paid in calendar year 2022. 7. Communications

Briana Barr is the new Board UI Advisory Representative. She is in her first year of her Master's study in Urban Planning with a focus on transportation issues. Briana is very excited about learning what MTD does and how it affects the local community.

8. Reports

A. Managing Director

Mr. Gnadt reviewed October statistics. While October 2021 monthly ridership increased 140% over last year, our numbers are 28,000 lower than September 2021 due to the staff shortages and service cuts. Recent training classes have increased the number of new operators going into service, but this employee shortage situation will take a long time to resolve. Monthly operating revenue is 24.8% higher than last year mostly due to the return of fare collection. Uncharacteristically, our local diesel fuel source was unable to get fuel, so Maintenance had to secure a couple of shipments from the Chicago area.

9. Action Items

A. Ordinance No. 2021-3 - General Tax Levy Ordinance for 2021

To comply with annual taxation laws, the Board must approve an estimated tax levy amount for the District in revenue year 2021 to be paid in calendar year 2022.

B. Development Agreement between MTD and Core Champaign Hockey, LLC In November 2019, MTD received a \$17,275,000 federal grant for The Yards Project - the renovation/expansion of Illinois Terminal, expansion of the bus platforms, and construction of a mixed-use facility. The District committed \$7,725,000 from its local capital reserve account to supplement the grant funding for a total of \$25,000,000. With this development agreement, Core Champaign Hockey, LLC. (Core) and the District are collaborating on The Yards project. At this time, the total estimated project cost is \$69,200,000. Core will contribute \$40,200,000, and MTD will contribute \$29,000,000 (the District will provide an additional \$4,000,000 from the Federal 5307 Formula to the already approved amount of \$25,000,000).

Mr. Gnadt commented that the \$69,200,000 cost is just an estimate. Once the Architectural/Engineering firm has been selected, a detailed cost estimate will be determined. This project encompasses the area from Logan Street to University Avenue and the railroad tracks to Market Street.

C. Hydrogen Station (Trillium) Change Orders #8 and #10

During the production station construction, the contractor had to remove contaminated soil and pay additional environmental fees for disposal. To avoid schedule delays, the Managing Director approved the related change orders for a total of \$60,627. The cost of the change orders will be covered with 100% federal funding.

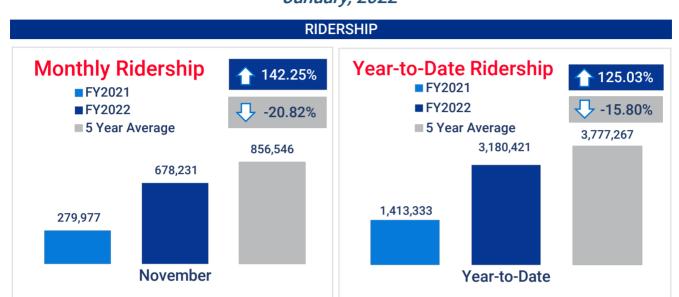

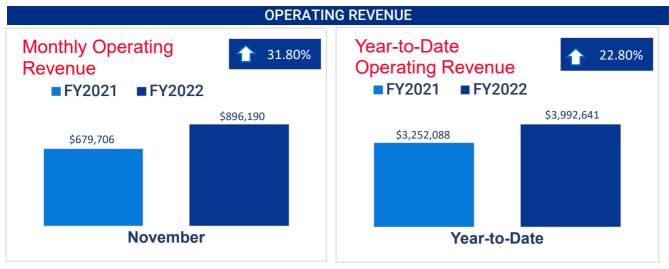


There were 678,231 rides in November 2021, which is 142% (398,254 rides) more than November 2020. Compared to prepandemic November 2019, ridership is down around 400,000 rides (-37%).

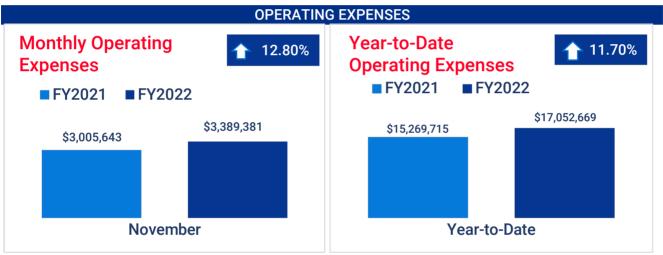
November 2021 ridership is down around 145,000 rides (-18%) from October 2021. This month-to-month decline happens every year because there are no service breaks in October but November has the week-long Fall Break.



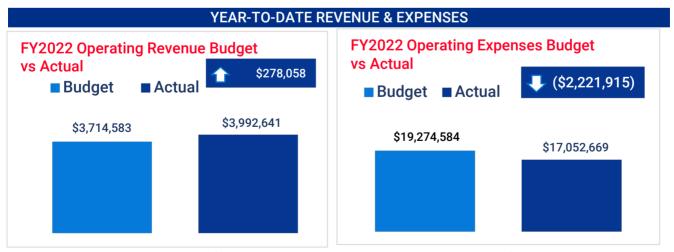




November, 2021 operating revenue was 31.80% above November, 2020, and year-to-date operating revenue was 22.80% above FY2021.



November operating expenses were 12.80% above November, 2020. Year-to-date operating expenses were 11.70% above FY2021.



Year-to-date operating revenues were \$278,058 above budget while operating expenses were \$2,221,915 below budget.



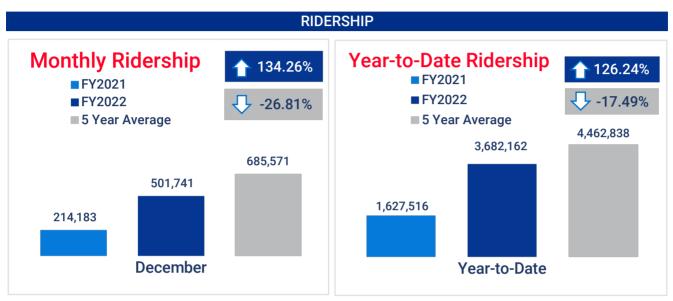

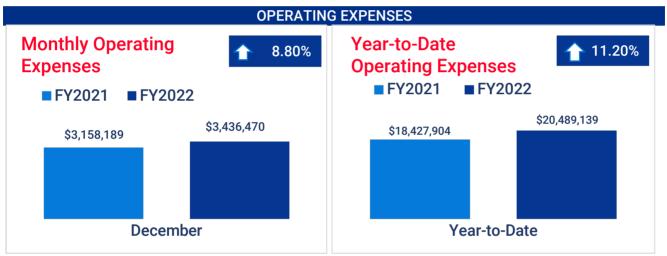


There were 501,741 rides in December 2021, about 288,000 rides (134%) more than last December, but still down about 372,000 rides (43%) from pre-Covid December 2019. December 2021 ridership dropped from November because it had one more week of Non-UI service and two no-service evenings (Christmas eve and New Year's eve). November to December ridership always drops because Winter Break is longer than Fall Break, however this year's drop was a bit heavier at (-26%) than the 5-year average (-20%).

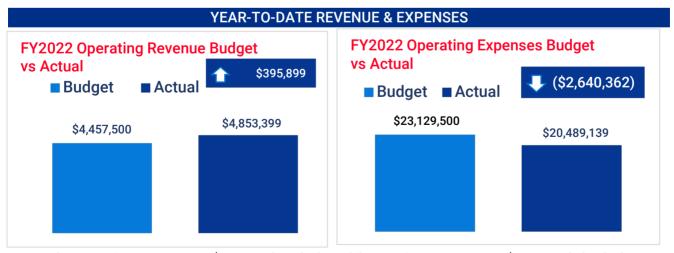




December, 2021 operating revenue was 23.20% above December, 2020, and year-to-date operating revenue was 22.90% above FY2021.



December operating expenses were 8.80% above December, 2020. Year-to-date operating expenses were 11.20% above FY2021.



Year-to-date operating revenues were \$395,899 above budget while operating expenses were \$2,640,362 below budget.

MANAGING DIRECTOR'S NOTES

- 1) In an effort to expand and support MTD employees, Human Resources has posted three Temporary COVID-19 Testing Associate positions to run our saliva testing lab. Once hired, these new employees will help run the lab from 7:00AM 7:00PM on Mondays through Saturdays, starting January 24. This expands our hours from 5.5 hours per day to a full 12 hours in order to be more convenient for our three shifts of employees. With expanded hours, we plan to open the lab to immediate family and household members of our MTD employees as well. Saliva testing is a PCR test and results often come in the evening of the same day that the test was taken, or early the following morning.
- 2) The COVID pandemic is proving to be a paradox for Operations. We want to provide service that is as close as possible to our scheduled service. However, there are more absence calls than ever and many of those are out for a minimum of five days. To give us flexibility, we created some safety valves in the Operator workboard with runs that can be easily removed. In October, we pulled those runs but they were not enough. We are struggling to adapt to the associated absences that the Omicron variant is causing. The paradox is that we need to cut service without knowing how much we need to cut. The logistics of our planning software, Operator workboard pick, and scheduling software limit our flexibility. We want to walk the tight rope of providing as much service as possible, while maintaining some reliability, yet cutting enough that we can operate what we communicate publicly. We try to do this while guaranteeing enough hours not to lose any Operators. We have fallen down lately with same day sick calls and having to communicate cuts the day of. This affects our reliability and reputation, leaving our affected passengers to lose confidence in our service.

In October, the runs that were cut were weekday runs. Beginning January 17, we cut some weekend runs and just a few more additional weekday ones. Previously, we were operating 18% less than our full service. This will bring us to 20% less. We put out press releases and social media information starting on Friday, January 14. All of the electronic schedule information has been updated to reflect the accurate level of service.

3) MTD has partnered with several other transit agencies and original equipment manufacturers (OEM) to form the Hydrogen Fuel Cell Bus Council. It was launched on January 18 and has quickly gained national attention. The press release follows:

Coalition created to expand the development, deployment, and utilization of hydrogen fuel cell electric buses

WASHINGTON, D.C. (Jan. 18, 2022) – The Hydrogen Fuel Cell Bus Council (HFC Bus Council) has formed a first-of-its-kind national coalition of public transit agencies, manufacturers, and suppliers working together to advance the hydrogen fuel cell electric bus economy and its applications in the public transit sector. The formation of the HFC Bus Council comes at a time of historic levels of investment in public transit, alongside nationwide commitments to transition fleets to zero emission propulsion.

The mission of the HFC Bus Council is to educate policymakers, regulators, and transportation stakeholders on the benefits of hydrogen fuel cell electric buses and related infrastructure. Through effective education and advocacy, the HFC Bus Council will expand the development, deployment, and utilization of safe, clean, and efficient hydrogen fuel cell electric buses, and create additional market opportunities to advance hydrogen fuel cell technology in the delivery of public transit services.

"I'm proud to be serving on the Founding Board of this organization, working to educate government officials and my colleagues in the transit industry on the viable and scalable zero emission solution that is hydrogen fuel cell technology," said Karl Gnadt, HFC Bus Council Board President and Managing Director/CEO of the Champaign-Urbana Mass Transit District (MTD).

The HFC Bus Council members share in the commitment to advance an environment that supports investments in and the deployment of hydrogen fuel cell electric bus technology. Founding members include MTD, SunLine Transit Agency, Stark Area Regional Transit Authority, Foothill Transit, Regional Transportation Commission of Southern Nevada, Utah Transit Authority, Indianapolis Public Transportation Corporation (IndyGo), Interurban Transit Partnership (The Rapid), Intercity Transit, Sangamon Mass Transit District, Regional Transportation Commission of Washoe County, NFI Group, ENC, Hexagon Purus, Trillium Energy Solutions, Ivys Energy Solutions, Ballard, and Nel Hydrogen.

The HFC Bus Council supports the adoption of battery electric propulsion systems and encourages the use of local, state, and federal resources to further build upon existing zero emission technologies. Subject: Approval of 2022 - 2024 Leasing Services Agreement

A. Introduction – The purpose of the bidding process for a leasing arrangement is to meet Illinois Department of Transportation (IDOT) requirements for reimbursement of operating leases and the District's own procurement policies for leasing services.

B. Recommended Action: Staff recommends authorization of the Managing Director to enter into an agreement for Leasing Services with Chelsea Financial Group, LLC. for the period February 1, 2022 through January 31, 2024.

C. Prior Trustee Action

- On January 29, 2020 the Board of Trustees authorized the Managing Director to enter into an agreement for Leasing Services with Chelsea Financial Group for a lease factor of .02454.
- On January 30, 2019 the Board of Trustees authorized the Managing Director to enter into an agreement for Leasing Services with Chelsea Financial Group for a lease factor of .02494.
- On January 31, 2018 the Board of Trustees authorized the Managing Director to enter into an agreement for Leasing Services with Ontario Investments, Inc. for a lease factor of .02388.
- **D. Summary:** Two proposals were received in response to the Request for Proposals for the provision of leasing services. The proposal with the lowest leasing rate was submitted by Chelsea Financial Group with a lease payment factor of .023895, based upon the current Prime Rate of 3.25%.
- **E. Background:** Leasing of equipment, vehicles, and associated capital items qualify as an eligible expense for the Illinois Downstate Operating Assistance Program (DOAP). Up to 65% of eligible expenses are reimbursed by the State through this program. In order for a lease to qualify as an eligible expense the total cost of the item including all lease payments must be greater than \$10,000 and the following must be true:
 - The transfer of ownership of the property to the District at the end of the lease may not be a term of the agreement;
 - Lease may not contain a bargain purchase option; and
 - The lease term must be for a period of time which is less than 75% of the estimated useful life of the leased property.

F. Alternatives – advantages/disadvantages

- 1. The advantage of approving this agreement is the ability for the District to continue leasing equipment and vehicles.
- 2. Our current Leasing Services Agreement with expire on January 31, 2022 and lack of approval will suspend the District's ability to enter into new leases.
- **G. Budget & Staffing Impacts:** Staff does not anticipate an additional cost or staffing impacts related to the approval of the Leasing services Agreement.
