MINUTES

1. Call to Order

Chair Diel called the meeting to order at 3:01 p.m. Mr. Diel took a moment to remember all those who lost their lives at Pearl Harbor on 12/7/1941.

2. Roll Call

A quorum was declared present.

3. Approval of Agenda

MOTION by Mr. Hannon to approve the agenda as distributed; seconded by Mr. Fiscella. Upon vote, the MOTION CARRIED.

Ms. Chaplan entered the meeting.

4. Public Hearing on General Tax Levy Ordinance for 2022

Mr. Diel asked for public input on the General Tax Levy Ordinance of the Champaign-Urbana Mass Transit District for revenue year 2022 to be paid in calendar year 2023. "Notice of the Proposed Tax Increase for the Champaign-Urbana Mass Transit District" appeared as a black bordered notice in *The*

Champaign-Urbana Mass Transit District Board of Trustees

News Gazette on November 25, 2022, and the proposed tax levy was posted on the District's website, mtd.org under Financial Documents for public review on November 18, 2022.

Mr. Harold Diamond of Urbana felt that MTD's tax levy was too high.

As there were no more public comments, Mr. Diel closed the Public Hearing.

6. Approval of Minutes

A. Board Meeting Open Session - October 26, 2022

MOTION by Mr. Fiscella to approve the open session minutes of the September 28, 2022 MTD Board meeting as distributed; seconded by Ms. Chaplan. Upon vote, the MOTION CARRIED.

8. Reports

A. Managing Director

Mr. Gnadt reported on October statistics. Ridership continued a strong recovery from the pandemic levels with a 15.42% increase from last October. Monthly operating expenses are 10.3% higher than last October mostly due to the increase in fuel prices.

B. For Discussion Only

1) Commercial Real Estate Representation

Mr. Nudo recommended using the services of a commercial real estate broker to represent MTD in transactions like the purchase, sale, or lease of property. Staff and the Administration Chair and Vice-Chair Board Committee of the Whole will develop a draft Request for Qualifications to be brought back to the Board for discussion.

2) The Yards Update

MTD is in the midst of conversations with government entities and private individuals as the Illinois Terminal Expansion project continues to move forward. Construction costs have increased approximately 25% as a result of the pandemic and other factors, so the scope of the project and the development partners may be modified. In utilizing Board closed sessions, Mr. Nudo would like the Board to be apprised of contractual changes in the project before they occur.

9. Action Items

A. Ordinance No. 2022-5 - General Tax Levy Ordinance for 2022

To comply with annual taxation laws, the Board must approve an estimated tax levy amount for the District in revenue year 2022 to be paid in calendar year 2023.

MOTION by Ms. Chaplan to adopt Ordinance No. 2022-5 General Tax Levy Ordinance for Champaign-Urbana Mass Transit District in the amount of \$11,724,226 for revenue year 2022 payable 2023; seconded by Mr. Hannon.

B. Ratification of the Approval Action for the 2022-2023 Urbana School District #116 Transportation Agreement for the 10/26/2022 Board Meeting

At the October 26, 2022 Board meeting, the Trustees unanimously approved the 2022-23 Urbana School District #116 Transportation Agreement without making a formal motion or second. This ratification will confirm the approval of the transportation agreement.

 MOTION by Mr. Hannon to ratify the approval at the 10/26/2022 Board meeting of the 2022-2023 Urbana School District #116 Transportation Agreement with MTD; seconded by Mr. Barnes. Upon vote, the MOTION CARRIED

C. Purchase of Four 60-foot Diesel Electric Hybrid Buses

MTD would like to exercise an option on its New Flyer 5-year bus procurement contract to purchase four 60-foot articulated diesel electric hybrid buses to replace four 2009 60-foot hybrid buses that are beyond their useful life. Cummins is the only supplier of the 60-foot hybrid certified engine, and they intend to discontinue their production of this engine after 2023. The \$5,077,032 total price will be funded with 80% federal and 20% local money.

MOTION by Mr. Fiscella to authorize the Managing Director to issue a purchase order to New Flyer in the amount of \$5,077,032 for four 60-foot diesel electric hybrid buses; seconded by Mr. Hannon. Upon vote, the MOTION CARRIED

D. Cooperative Purchasing Agreement with the Washington State Department of Enterprise Services
To purchase ten 40-foot hydrogen fuel cell electric buses (FCEB) from New Flyer, MTD will use a federally compliant, cooperative purchasing agreement developed by the Washington State Department of Enterprise Services (DES). DES has contracted with vendors to provide transit buses and related equipment to multiple participants, including transit agencies from other states.

MOTION by Ms. Chaplan to authorize the Managing Director to execute a Cooperative Purchasing Agreement with the Washington State Department of Enterprise Services to purchase New Flyer hydrogen fuel cell electric buses; seconded by Mr. Hannon. Upon vote, the MOTION CARRIED

E. Purchase of Ten 40-foot Hydrogen Fuel Cell Electric Buses

Using the DES cooperative purchasing agreement, MTD would like to purchase ten 40-foot hydrogen fuel cell electric buses from New Flyer to replace ten 40-foot diesel electric hybrid buses purchased in 2011 that are beyond their useful life. MTD's hydrogen production station and fueling infrastructure can accommodate the ten additional buses. The total cost of this bus procurement is \$12,959,080 and will be paid by Federal Community Project Funding (earmarks) \$3,785,080, Federal Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) \$8,051,564, and local funds \$1,122,436.

MOTION by Mr. Hannon to authorize the Managing Director to issue a purchase order to New Flyer in the amount of \$12,959,080 for ten 40-foot hydrogen fuel cell electric buses; seconded by Mr. Fiscella. Upon vote, the MOTION CARRIED

F. <u>Hydrogen Fuel Cell Project Technical Assistance Contract with the Center for Transportation and the Environment (CTE)</u>

This contract with the Center for Transportation and the Environment (CTE) will provide technical assistance to MTD in data reporting of the FCEBs, support in the purchase/bus build of the ten new FCEBs, and station management. The contract cannot exceed \$204,500, and the work will be completed by 6/30/2024. MTD has worked with CTE since 2017 on the initial phase of the hydrogen project. This contract will be funded with 29% state and 71% local money.

MOTION by Mr. Hannon to authorize the Managing Director to execute a contract with the Center for Transportation and the Environment in an amount not to exceed \$204,500; seconded by Mr. Fiscella. Upon vote, the MOTION CARRIED

G. Training Simulator Contract

Simulator training is an important Safety and Training tool used as an immersive driving experience for new operator trainees and also for retraining existing operators. MTD currently has two simulators purchased in 2010 that are out of warranty and are in need of frequent technical support. A request for proposals was issued on 6/27/2022, and two proposals were received. The Evaluation Committee recommended the \$765,243 purchase of one simulator from FAAC, Inc. The simulator purchase will be funded with 100% federal money through the American Rescue Plan Act of 2021 (ARPA).

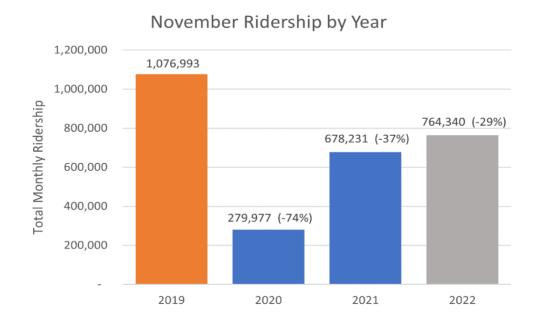

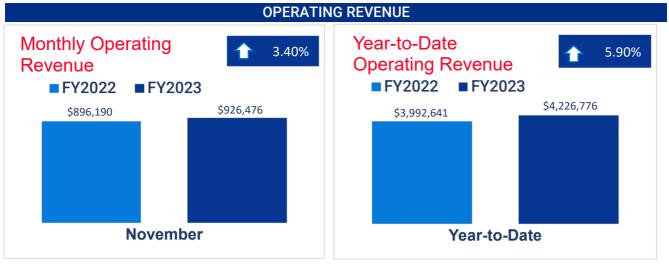

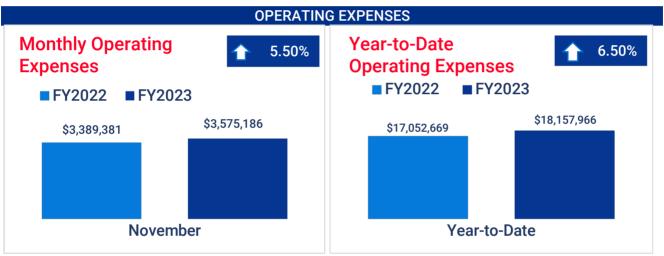

There were 764,340 rides in November 2022. This is up nearly 13% (~86,000 rides) from last November and down 19% from October (our busiest month) because of Fall Break, Thanksgiving, and because the school districts had more days off.

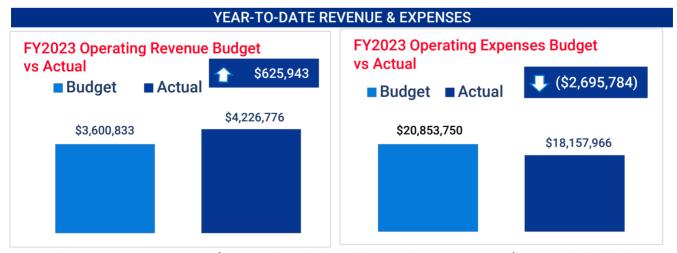




November 2022 operating revenue was 3.40% above November 2021, and year-to-date operating revenue was 5.90% above FY2022.

Year-to-date operating revenues were \$625,943 above budget while operating expenses were \$2,695,784 below budget.



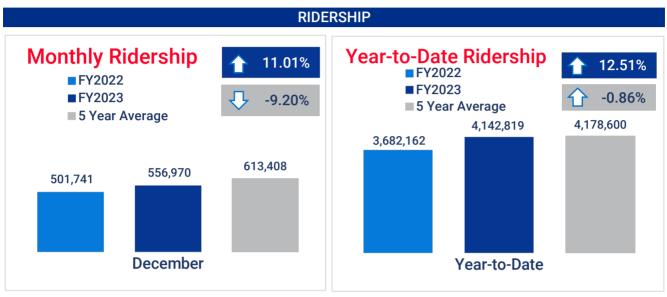

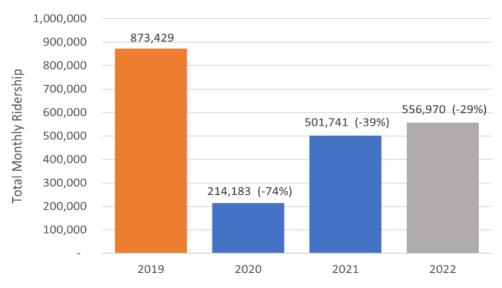

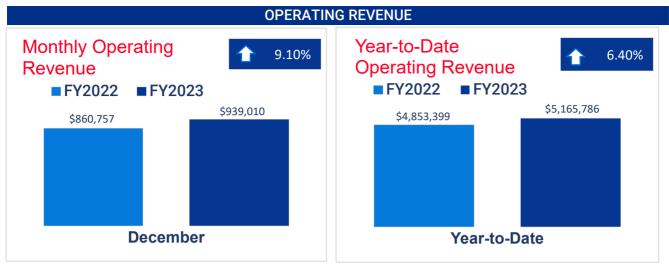

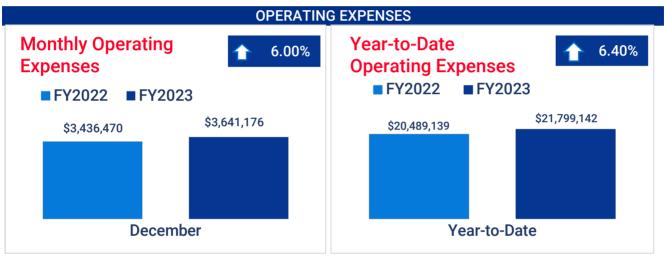
There were 556,970 rides in December 2022. This is up 11% (~55,000 rides) from last December and down 27% from November because of Winter Break, Christmas, and because the school districts had more days off. Passenger revenue hours were better than 2020's hybrid service but less than last year. This is due to the second round of service cuts that took place after winter break in January 2022.

December Ridership by Year

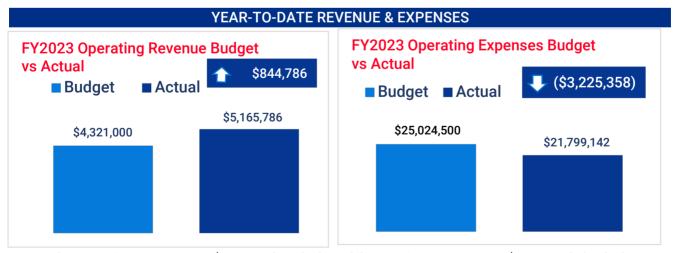




December 2022 operating revenue was 9.10% above December 2021, and year-to-date operating revenue was 6.40% above FY2022.



December operating expenses were 6.00% above December 2021. Year-to-date operating expenses were 6.40% above FY2022.



Year-to-date operating revenues were \$844,786 above budget while operating expenses were \$3,225,358 below budget.

MANAGING DIRECTOR'S NOTES

1) On Tuesday, January 17, 2023 I attended Sangamon Mass Transit District's (SMTD) press conference announcing their \$5.9 million Low-No Grant funding. They will be procuring four CNG buses and their first four diesel electric hybrids. On hand were transit officials from across the state – we had a board meeting for the Illinois Public Transportation Association just prior to the event. Also attending were Senator Dick Durbin and Congresswoman Nikki Budzinski.

2) On January 1, 2023, Carle Occupational Medicine became our third-party administrator for our drug and alcohol program. As with anything new, growing pains are to be expected. Two randoms were performed on 1/3/22, both of them came with testing errors. The good news is that the program coordinator at Carle caught the testing errors, generated the necessary documentation, and mitigated the issue to prevent future occurrences the very same day. What's most exciting for S&T regarding this transition is that Carle uses a service called eScreen that not only tracks all tests but also generates the MIS report for year-end reporting. This will ensure accuracy and will only require the Safety Program Manager to confirm and submit to the FTA.

3) When asked, many Operators will say their number one problem when driving comes from dealing with passengers who are in crisis due to mental health, substance use, or homelessness. The Operations Department has been working to resolve these challenges for Operators since early 2020. Operators and Supervisors received training in how to handle trauma-induced situations. New procedures have been implemented for crisis situations.

One concern that remained unresolved was how to provide services to effected passengers to mitigate future crisis, in line with the District promotion as a Safe Haven for the community. Specifically, Operations has been pursuing a community team to respond to buses and facilities and provide specialized services for passengers who otherwise would simply be removed and left to themselves.

After meeting and working with organizations and public service agencies for two years, the final pieces are in place. Following a series of Operations Meetings to introduce MTD Supervisors to the community individuals involved, Operators working through Supervisors have now been given access to law enforcement, mental health, substance use, and homelessness professionals who will respond to their location if necessary and provide much-needed services to any willing passenger. Specially trained Urbana and University of Illinois Police Officers partnered with mental health professionals will respond to people in crisis on a bus or in a facility, and MTD Supervisors will provide transportation for those in crisis to community facilities such as Strides Homeless Shelter, The Living Room at Rosecrance, or a local hospital. The agencies MTD is actively working with include CU@Home, Strides Homeless Shelter, Urbana Police Department, University of Illinois Police Department, Rosecrance, Carle Recovery Center, Champaign County Probation Dept, and Champaign County State's Attorney's Office.

4) SafeRides Connect launched with Via on December 19th. This was the first Monday of Winter Break and this date was chosen because it is a low exposure opportunity to roll out the new service with fewer vehicles and lower passenger demand. We used this time to work out any bugs or issues that we hadn't anticipated prior to launch, and there were a few. Mostly the issues revolve around getting the vehicles and drivers appropriately assigned and logged in prior to the service starting. Other minor issues include connectivity, charging, data, or GPS issues on the tablets that run the driver software. We are trying to understand and resolve those issues as we come across them.

We sent out several messages through social media and to the old Routematch app to alert passengers that the Routematch app wouldn't work anymore and that they would need to sign up for the Via app. And unfortunately, both apps are still in the app stores. We are working to get that corrected too.

Ridership during the Winter Break was generally low, which may have been due to the transition, the extremely cold weather, and ironically the warmer weather we've experienced so far since launch. Since the University has returned for the Spring semester, booking attempts and ridership continue to be lower than usual. For example, in the first Sunday through Wednesday of full service last year, we had 409 rides compared to the 72 that we had this year.

We will continue to keep an eye on how things are operating, like when SafeRides trips are offered or when it offers fixed route trip information. We haven't heard any complaints so far, nor have we fielded many calls about the Routematch app not working so we feel pretty good so far. All of our testing for valid SafeRides vs. offering fixed route trip information seems reasonable. As the semester continues, we will meet with student groups a few times to solicit feedback and continue to monitor complaints (if we get any) and social media posts. Feedback from the Drivers and Dispatchers has been very positive both for ease of use and accuracy of directions and reliability.

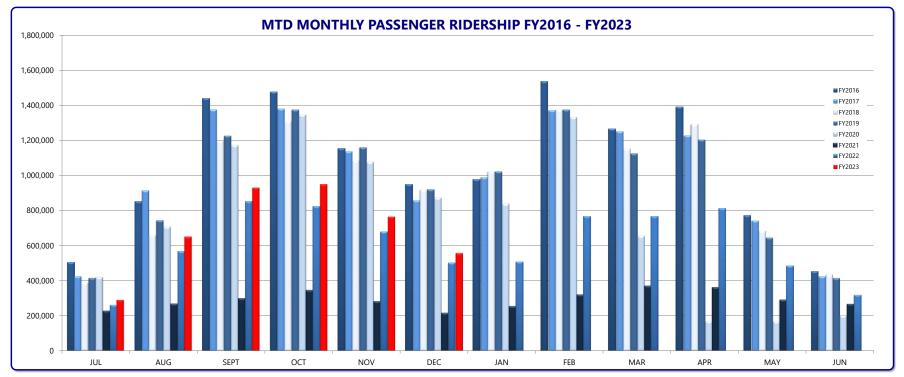

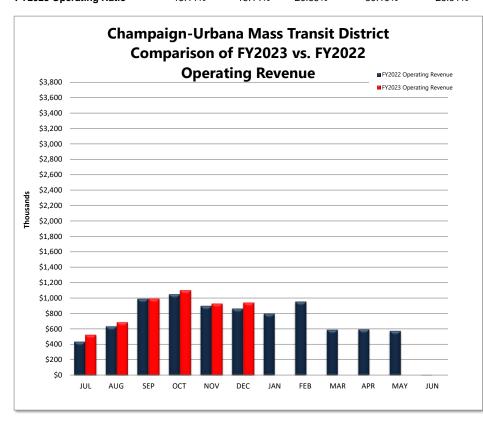

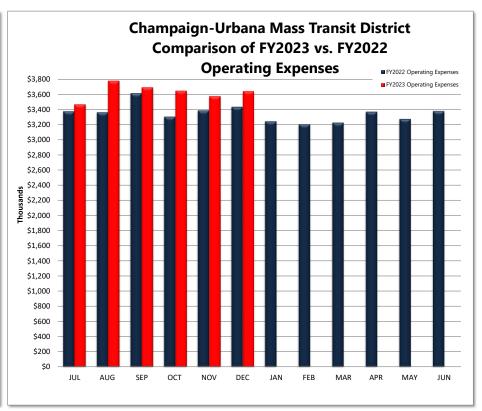

Subject: Semi-Annual Review of Closed Session Minutes

4. Prior Trustee Action

The last semi-annual review by the Board was July 27, 2022.

5. Background:

Closed Sessions allow the MTD Board of Trustees to discuss certain matters of a sensitive nature which affects MTD. Areas that may be discussed in Closed Session are specified in the Illinois Open Meetings Act and include the appointment/employment or dismissal of an employee or officer, land acquisition or sale, and probable or pending litigation involving MTD. When a motion is made to adjourn to a Closed Session, only that specific topic can be discussed, and no final action may be taken on it during the Closed Session. After the Board has determined that it is no longer necessary to protect the public's interest or the privacy of an individual, minutes of the Closed Session are made available to the public.

6. Summary: Schedule 1 lists all closed session minutes by date that are recommended to be released. Schedule 2 lists those minutes that should remain confidential mostly due to privacy concerns from past workers' compensation cases involving current MTD employees.

The statutes permit the destruction of verbatim recordings of closed sessions if they are not less than 18 months old and the written minutes have been approved. Schedule 3 is a list of those closed meetings that meet that criteria and should be destroyed.

WHEREAS, Buyer has examined such Real Estate and desires to purchase the same; and WHEREAS, The parties have agreed upon the terms and conditions relating to the sale and purchase of said Real Estate and now wish to reduce their said agreement to writing in this Contract.

NOW, THEREFORE, It is agreed between the parties as follows:

- 1. <u>COVENANT OF SALE AND PURCHASE</u>. Seller hereby agrees to sell and convey the Real Estate above described to the Buyer and the Buyer hereby agrees to purchase said Real Estate and pay for the same in the manner and at the times herein stated.
- 2. **SELLING PRICE.** The gross selling price of said Real Estate is the sum of One Million One Hundred Thousand and no/100 Dollars (\$1,100,000.00). The selling price shall be paid to Seller as follows:
 - a. The sum of Zero Dollars (\$0.00) cash earnest money, receipt of which is hereby acknowledged, with said amount to be held by Seller's attorney, O'Byrne, Stanko & Jefferson, P.C. ("Escrow Agent") to be applied against the purchase price at Closing or as otherwise provided herein;
 - b. The sum of One Million One Hundred Thousand and no/100 Dollars (\$1,100,000.00) at the Closing, upon delivery of possession and upon receipt of satisfactory evidence of title; such payment shall be paid in lawful money of the United States, by cashier's check, certified check or bank check, or such other payment as selected by Seller. The purchase price payable at Closing shall be adjusted by prorations and credits allowed the parties under this Contract, and adjusted by usual and customary credits for Seller's expenses paid by Buyer at Closing.
- 3. <u>DEED OF CONVEYANCE</u>. As soon as practicable, Seller shall execute a recordable Warranty Deed sufficient to convey the Real Estate to Buyer in fee simple absolute,

subject only to exceptions permitted by this Contract, to be held by the Seller's attorney, as escrow agent, for both parties and delivered to Buyer at the Closing of this transaction upon Buyer's compliance with the terms of this Contract.

- 4. **POSSESSION.** Delivery of possession of said Real Estate and delivery of said deed shall occur contemporaneously with the payment of the purchase price, and the Closing of this Contract, which shall occur within fifteen (15) days following the approval by the Board of Directors of Buyer of the purchase of the Real Estate, or such later date as may be agreed upon by the parties (the "Closing" or "Closing Date"). Said Closing shall be held at a title company, Buyer's lender, or such other place or places as the parties may mutually agree upon.
- 5. **PERSONAL PROPERTY.** Title to all personal property belonging to the Seller located at the premises shall pass to Buyer at Closing without the necessity of additional instruments of conveyance. Notwithstanding the foregoing, Buyer agrees that prior to Closing, Seller, at Seller's sole cost and expense, may remove the chain link fence currently located on the Real Estate for Seller's use elsewhere.
- 6. <u>LEASES, RENTS AND SECURITY DEPOSITS</u>. On the Closing Date or immediately prior to the Closing, the existing lease between Seller and the existing tenant shall be terminated and Seller shall provide written evidence of such termination to Buyer prior to Closing.

Seller shall pay prior to Closing or give credit to Buyer at the time of Closing for all general real estate taxes and special assessments now a lien on the Real Estate except the general taxes for the current year, which shall be prorated between the parties as of the date of delivery of possession on the calendar year basis, using the last ascertainable tax figures for such computation. Seller shall give credit at the Closing for its prorated share of the said current taxes. Special assessments levied after the date hereof and general taxes for future years shall be paid by the Buyer. Transfer taxes due as a result of the sale of the Real Estate shall be Seller's expense, and Seller shall furnish a complete real estate Transfer Declaration signed by

11. <u>CONDITION OF PREMISES</u>. The Buyer has examined the Real Estate, including the improvements thereon, and Buyer is acquainted with the condition thereof. Subject to normal wear and tear, Buyer accepts the same as of the time Buyer executes this Contract in AS-IS CONDITION. BUYER SPECIFICALLY ACKNOWLEDGES AND AGREES THAT (A)

EXCEPT AS EXPRESSLY SET FORTH IN THIS CONTRACT. SELLER SHALL SELL AND BUYER SHALL PURCHASE THE REAL ESTATE AND PERSONAL PROPERTY "AS IS, WHERE IS AND WITH ALL FAULTS", AS OF THE DATE OF THIS CONTRACT AND AS OF THE CLOSING DATE, AND (B) EXCEPT AS EXPRESSLY SET FORTH IN THIS CONTRACT, BUYER IS NOT RELYING ON ANY REPRESENTATIONS OR WARRANTIES OF ANY KIND WHATSOEVER, WHETHER ORAL OR WRITTEN, EXPRESS OR IMPLIED, STATUTORY OR OTHERWISE, FROM SELLER AS TO ANY MATTER, CONCERNING THE REAL ESTATE AND PERSONAL PROPERTY, INCLUDING WITHOUT LIMITATION: (i) THE QUALITY, NATURE, HABITABILITY, MERCHANTABILITY, USE, OPERATION, VALUE, MARKETABILITY, ADEQUACY OR PHYSICAL CONDITION OF THE REAL ESTATE AND PERSONAL PROPERTY OR ANY ASPECT OR PORTION THEREOF, INCLUDING, WITHOUT LIMITATION, STRUCTURAL ELEMENTS. FOUNDATION. ROOF. APPURTENANCES. LANDSCAPING, PARKING FACILITIES, ELECTRICAL, MECHANICAL, HVAC, PLUMBING, SEWAGE, AND UTILITY SYSTEMS, FACILITIES AND APPLIANCES, SOILS, GEOLOGY AND GROUNDWATER, (ii) THE DIMENSIONS OR LOT SIZE OF THE REAL ESTATE OR THE SQUARE FOOTAGE OF THE IMPROVEMENTS THEREON, (iii) THE DEVELOPMENT OR INCOME POTENTIAL, OR RIGHTS OF OR RELATING TO, THE REAL ESTATE, OR THE REAL ESTATE'S USE, HABITABILITY, MERCHANTABILITY, OR FITNESS, OR THE SUITABILITY, VALUE OR ADEQUACY OF THE REAL ESTATE FOR ANY PARTICULAR PURPOSE, THE ZONING OR OTHER LEGAL STATUS OF THE REAL ESTATE OR ANY OTHER PUBLIC OR PRIVATE RESTRICTIONS ON THE USE OF THE REAL ESTATE. THE COMPLIANCE OF THE REAL ESTATE OR ITS OPERATION WITH ANY APPLICABLE CODES, LAWS, REGULATIONS, STATUTES, ORDINANCES, COVENANTS, CONDITIONS AND RESTRICTIONS OF ANY GOVERNMENTAL AUTHORITY OR OF ANY OTHER PERSON OR ENTITY (INCLUDING, WITHOUT LIMITATION, THE AMERICANS WITH DISABILITIES ACT), THE ABILITY OF BUYER TO OBTAIN ANY NECESSARY GOVERNMENTAL APPROVALS, LICENSES OR PERMITS FOR BUYER'S INTENDED USE OR DEVELOPMENT OF THE REAL ESTATE, THE PRESENCE OR ABSENCE OF HAZARDOUS MATERIALS ON, IN, UNDER, ABOVE OR ABOUT THE REAL ESTATE OR ANY ADJOINING OR NEIGHBORING PROPERTY, THE QUALITY OF ANY LABOR AND MATERIALS USED IN THE CONSTRUCTION OF ANY IMPROVEMENTS. THE CONDITION OF TITLE TO THE REAL ESTATE, CONTRACTS OR ANY OTHER AGREEMENTS AFFECTING THE REAL ESTATE, SELLER'S TITLE TO OR OWNERSHIP OF THE REAL ESTATE OR ANY PORTION THEREOF OR THE ECONOMICS OF, OR THE INCOME AND EXPENSES, REVENUE OR EXPENSE PROJECTIONS OR OTHER FINANCIAL MATTERS, RELATING TO, THE OPERATION OF THE REAL ESTATE. WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, BUYER EXPRESSLY ACKNOWLEDGES AND AGREES THAT BUYER IS NOT RELYING ON ANY REPRESENTATION OR WARRANTY OF SELLER, NOR ANY REPRESENTATIVE OF SELLER, WHETHER IMPLIED, PRESUMED OR EXPRESSLY PROVIDED AT LAW OR OTHERWISE, ARISING BY VIRTUE OF ANY STATUTE, COMMON LAW OR OTHER LEGALLY BINDING RIGHT OR REMEDY IN FAVOR OF BUYER, EXCEPT AS EXPRESSLY SET FORTH IN THIS CONTRACT. THIS SECTION SHALL SURVIVE THE CLOSING, OR, IF THE CLOSING DOES NOT OCCUR, SHALL SURVIVE THE TERMINATION OF THIS CONTRACT.

- 12. **SELLER REPRESENTATIONS AND WARRANTIES**. Seller represents and warrants to Buyer as follows:
- a. That Seller has all necessary lawful authority to enter into this Contract and to carry out the transaction contemplated hereby; that the same do not violate any law, court or administrative order, regulation or bylaw or any agreement or other instruments to which Seller is subject; and that Seller has no knowledge or notice of any pending or threatened or pending litigation or governmental action which would adversely affect the value of the Property or the right of the Buyer to acquire the Property;
- e. That Seller shall use its reasonable efforts to satisfy the conditions hereof on or prior to Closing;
- f. That Seller shall pay all water, sewer, gas, and electrical or other utility charges accrued or accruing on or before the date of Closing;

- g. Neither Seller nor any authorized agent or representative of Seller has received, prior to the date of Seller's execution of this Contract, any notice from any governmental body describing or relating to any alleged violation at the Real Estate of any applicable zoning, building, dwelling, fire, electrical, health and safety, environmental protection or similar laws, statutes, ordinances, codes, rules or regulations which are uncurred or uncorrected as of the date of Seller's execution of this Contract;
- h. No person, firm or entity has any right of first refusal or first offer or any option to acquire title to the Property or any part thereof or interest therein;
- i. There are no contracts, agreements, service contracts, maintenance agreements, licenses, invoices, bills, understandings of any nature, written or oral, formal or informal, affecting or relating to the service, maintenance, use or other functions pertaining to the Property or the operation thereof which may not be terminated upon thirty (30) days' notice, and unless Buyer delivers a written notice to Seller to the contrary, shall be terminated at Seller's sole cost, effective as of the Closing Date; and
- j. Seller has no contractual obligations with vendors, managers, etc., other than as disclosed to Buyer which may bind Buyer or become a lien on the Real Estate.

All warranties contained herein shall survive the Closing of this transaction for twelve (12) months after the Closing Date.

DEFAULT. If Buyer fails to make any payment or to perform any obligation imposed upon Buyer by this Contract, Seller may serve written notice of default upon Buyer and if such default is not corrected within fifteen (15) days thereafter, Seller may, in Seller's sole discretion, terminate this Contract or pursue any other available remedy, including specific performance. In the event of failure of Seller to perform the obligations imposed upon Seller by this Contract, Buyer may serve written notice of default upon Seller and if such default is not corrected within fifteen (15) days thereafter, Buyer may, in Buyer's sole discretion, terminate this Contract or pursue any other available remedy, including specific performance. Default by any party of this Contract shall entitle the non-defaulting party to damages, reasonable costs, attorney's fees and expenses incurred by reason of the breach of this Contract.

The Escrow Agent, upon receiving an affidavit from the non-defaulting party stating that this Contract has been terminated as provided herein and evidencing service of a copy of said affidavit on the other party hereto by means, provided herein for notices, shall be entitled to rely upon such affidavit unless a counter-affidavit is received by the Escrow Agent within seven days of receipt by the Escrow Agent of the original affidavit. If no such counter-affidavit is received by the Escrow Agent, the Escrow Agent shall deliver the earnest money to the non-defaulting party. If such a counter-affidavit is served upon the Escrow Agent, the escrow agent shall hold all documents and the earnest money until directed otherwise by agreement of the parties or order of Court.

14. **NOTICES.** Any notice required under this Contract to be served on either Seller or Buyer shall be personally delivered or shall be mailed by certified mail to the addresses set forth below. Notice personally delivered shall be effective when received and notices sent by certified mail shall be effective when mailed. All notices shall be sent as follows:

- 15. **RESPA/TRA.** The parties hereto shall comply with the Real Estate Settlement Procedures Act of 1974 (RESPA), if applicable, and the Tax Reform Act of 1986 and shall promptly furnish all information and execute all documents required for such compliance.
- 16. **CONSTRUCTION.** The language used in this Contract shall be deemed to be the language approved by all parties to this Contract to express their mutual intent and no rule of strict construction shall be applied against any party.
- 17. **GOVERNING LAW.** This Contract shall be construed and interpreted in accordance with the laws of the State of Illinois.

- 18. **ENTIRETY OF AGREEMENT.** This Contract contains the entire agreement between the parties and no oral representation, warranty or covenant exists other than those herein set forth.
- 19. <u>SURVIVAL OF WARRANTIES</u>. All warranties contained herein shall survive the Closing of this transaction.
- 20. <u>TIME OF ESSENCE AND EXTENSION OF LIABILITIES</u>. Time is the essence of this Contract, and all of the agreements contained herein shall be binding upon the heirs, executors, administrators, successors, and assigns of the respective parties hereto.
- 21. LIKE-KIND EXCHANGE. Buyer acknowledges that Seller may wish to acquire other real estate as replacement property for the Real Estate being sold to Buyer. Buyer agrees to cooperate with Seller at no expense to Buyer to effect the transaction described in this Contract with respect to the Real Estate as a tax deferred exchange pursuant to Internal Revenue Code Section 1031. Buyer, upon Seller's request, agrees to execute such other documentation as may be requested by Sellers to accomplish the intent of this Section, including a novation of this Contract substituting an exchange owner or a third party intermediary for Seller under this Contract. Buyer shall not be obligated to take title to any exchange property to be acquired by Seller.
