1. Call to Order

7. Reports

A. Managing Director

Mr. Gnadt reviewed statistics for January 2025. The January 2025 ridership was up 1.8% from January 2024. Year to date ridership for January 2025 was up 19.33% compared to January 2024. It was noted there were three fewer U of I weekdays and one fewer U of I Saturday than in 2019, explaining the modest growth.

January 2024 operating revenue was 3.7% below January 2024. This is a result of the reduction in current interest rates. Year to date operating revenue was 0.5% above FY2024. Monthly operating expenses were up 5.8% from FY2024. Year to date operating expenses were up 6% from FY2024. January 2025 operating revenue was \$1,616,943 above budget and operating expenses were \$2,291,601 below budget.

Mr. Gnadt stated Market Place Mall has asked MTD to vacate their property. Beginning with the new service year in August, buses will no longer enter the mall property. Service to the area will continue with a stop at Center Drive and Neil Street.

B. Disadvantaged Business Enterprise (DBE) Program Presentation

Mr. Gnadt was joined by External Affairs Director, Ashlee McLaughlin, to provide an overview and discuss the Disadvantaged Business Enterprise program, which is updated every three years.

Ms. McLaughlin provided an overview of the program and explained some of the recent changes including a federal update from April 2024 and clarifications to design build contract performance plans. The DBE goal has been updated for fiscal years 2025-2027, which is 1.84% in federally funded contracts. This number has decreased from previous years due to removing the Illinois Terminal Expansion construction from the three year plan owing to construction delays.

D. Approval of Bus Procurement Purchase Order

Mr. Gnadt stated this purchase order is for expansion buses, not replacement buses. One of the reasons MTD is asking for this approval is to accommodate future additional services plans. This includes the Carle Clinic on Curtis which would require two additional buses. It was noted that bus orders take between 18-24 months; therefore, taking a proactive approach is essential.

Mr. Gnadt was joined by External Affairs Director, Ashlee McLaughlin, and Maintenance Director, Josh Berbaum. Ms. McLaughlin reviewed the purchase order memo and explained the purchase of eight diesel-electric hybrid buses would allow for an increased spare bus ratio of 20%. The current spare ratio is 15%. A higher spare ratio allows for more vehicles to be available for routine and unexpected maintenance at any given time as well as to accommodate training needs.

Mr. Berbaum explained MTD has been operating at a deficit at the 15% spare ratio mark. This has been challenging at times due to long lead times on vehicle part orders. The Maintenance Department has been proactive by keeping spare parts on hand when possible. Adding the additional eight buses would put MTD at the 20% allowable mark for spare buses per the Federal Transit Administration (FTA) and will help with the future service expansion plans of the District. Mr. Berbaum provided an overview of the current hydrogen fuel cell bus performance along with a hydrogen station performance update.

Mr. Gnadt clarified this purchase order is for hybrid buses, not hydrogen fuel cell buses, so that they can be immediately incorporated into the fleet once received. Once the current hydrogen fueling station has been expanded, allowing for more fueling capacity, more hydrogen fuel cell buses may be incorporated into the fleet.

MINUTES

1. Call to Order

Mr. Nudo called the Public Hearing to order at 4:00 pm. The purpose of this hearing was to consider annexation of the remaining plats of South Ridge Subdivision and Baptist Church Subdivision in Urbana into the Champaign-Urbana Mass Transit District. A legal description of the area being considered for annexation was published in The News-Gazette on February 10th, 25th, and March 7th of 2025.

The MTD Board of Trustees' Annexation Policy requires that the District boundary be routinely analyzed. MTD's planning area is to be contiguous with boundaries established by the Regional Planning Commission's Champaign Urbana Urbanized Area Transportation Study and our boundary is to be co-terminus with the boundaries of the communities served. Also, MTD has entered into an Intergovernmental Agreement with the City of Urbana on February 23, 2005, to annex any area so annexed by the city. To those ends, MTD is considering this annexation.

Mr. Nudo opened the hearing for public comment.

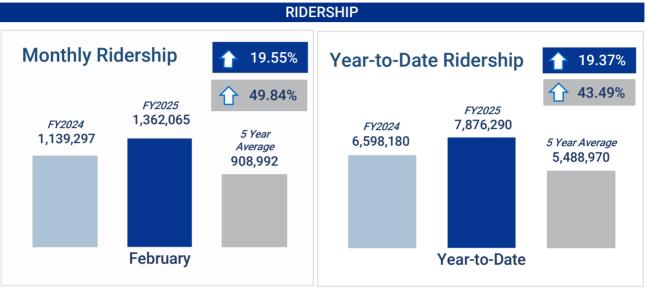

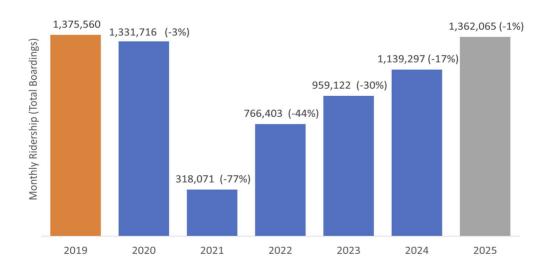
MTD MANAGING DIRECTOR OPERATING NOTES March 2025

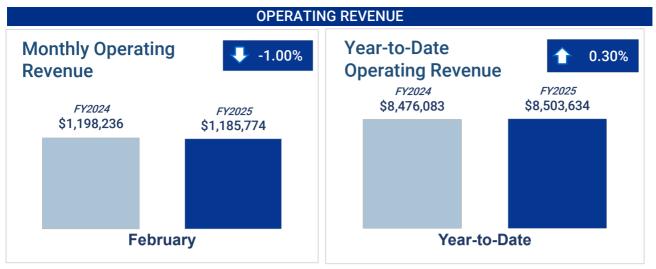


February total ridership reached 1,362,065, a 19.6% rise compared to last February. The FY YTD ridership reached 7,876,290, which is a 19.4% increase. Compared to last year, this February had one fewer weekday, while the rest of the day types remained the same.

The U of I Students rides increased dramatically in February, reaching 1.19 million rides, a 25.8% difference. Annual Pass rides also increased by 1.6%.

February Ridership by Year

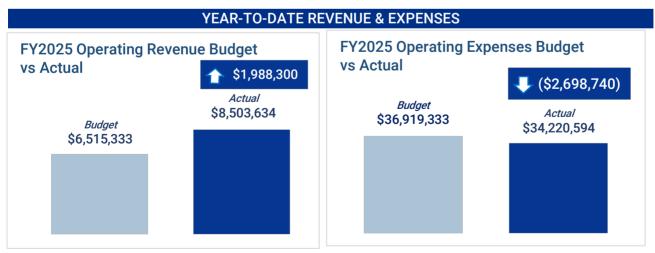




February 2025 operating revenue was 1.00% below February 2024. Year-to-date operating revenue was 0.30% above FY2024. The month over month decrease is due to a reduction in investment income as a result of falling interest rates.



February 2025 operating expenses were 5.30% above February 2024. Year-to-date operating expenses were 5.90% above FY2024.



Year-to-date operating revenues were \$1,988,300 above budget while operating expenses were \$2,698,740 below budget.

MANAGING DIRECTOR'S NOTES

- 1) Dave Goldenbaum (Service Planner) and Jay Rank (Operations Director) are working on new service year planning changes related to school service since the Urbana Middle School is splitting the sixth-grade students off to a new school at the old Wiley School site. They've been working out the routing, timing details, and bus assignments and their conclusion is the service will need two additional buses to adequately serve the schools. Adding two buses in the afternoon opens the opportunity to address some known challenges with schedule adherence with the Champaign Unit 4 service. We are currently working with Unit 4 to advance our recommendations and soliciting feedback on issues. We hope to finalize the proposed service changes in the next month or so.
- 2) As I mentioned during February's Board Meeting, Market Place Mall has denied MTD access to their property starting in August 2025. Staff anticipated this and have plans ready for new routing options.
 - Changes to the Yellow and Red routes have become the major planning effort for our next service change in August. Staff are working on concepts, routing options, trip times, and all of the other preliminary research to help guide the process until we land on a final service plan to present.
- 3) As our community prepared for a potentially dangerous storm late Friday, March 14, MTD Staff worked to have a game plan. Our initial plan was to have buses go to Illinois Terminal if there was severe weather. Illinois Terminal is centrally located and on route for several of the buses already. Depending on what time the storm system came through, the building may or may not have been open. We felt that even if the building was closed, the platform areas would provide some protection, especially from wind. Since this is the beginning of Spring Break, campus buildings wouldn't be open. We were expecting a short-lived storm with up to 60-70 mph winds, so buses would wait it out and then continue on route after the front passed.

On Friday night around 12:30A, the storm came. Then the tornado warning sirens went off. Then everyone's phone alarm went off. As we watched the weather coverage, it was clear that the expected path of a potential tornado was heading directly toward Champaign-Urbana. We quickly decided that since Illinois Terminal was closed, it wasn't a viable option for a tornado shelter. We made the decision to pull service and send the buses to the MTD garage in Urbana, where they would park, and the Operators and any passengers on board could take shelter in our Maintenance Break Area. Several Operators and about 15 passengers took shelter there. Nicole Nesbitt, Dispatch Supervisor, came in to help our Radio Operators, coordinate with Maintenance, and arrange service restoration. She had an extra bus and several SafeRides vans drop passengers off as efficiently as possible while restoring fixed-route service immediately.

It is never easy to decide to disrupt service, but the safety of the Operators and passengers on board took priority. Fortunately, the storm passed and there wasn't much local damage. Nobody was hurt and we haven't received any complaints about the service disruption. Every storm is different and we continue to look for lessons learned.

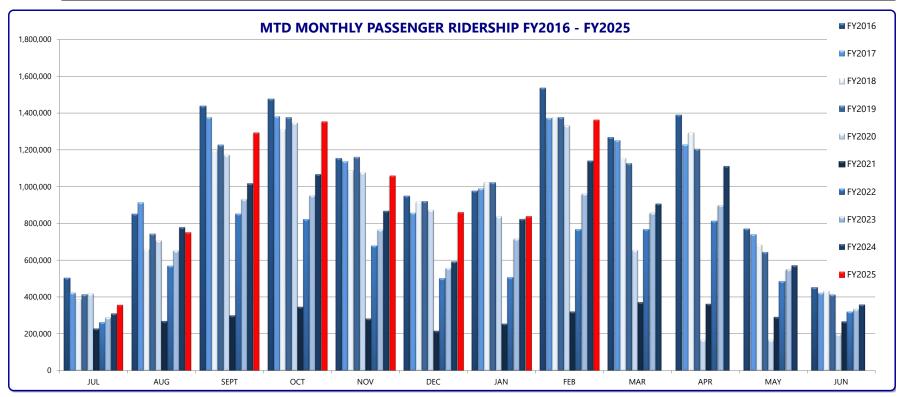

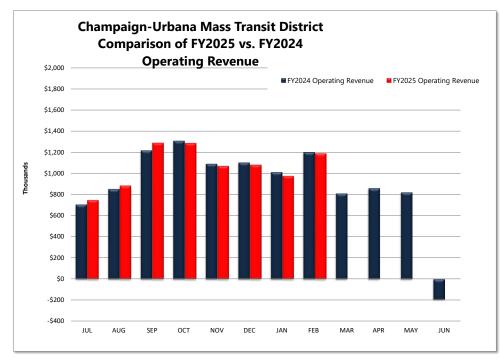

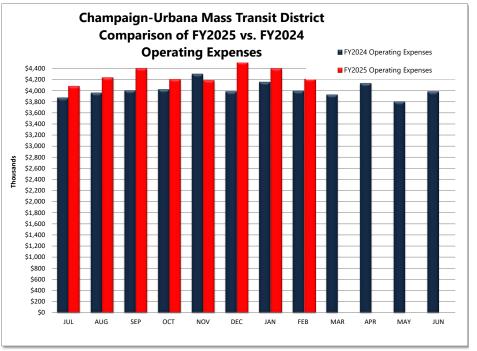

ORDINANCE NO. 2025 - 1

AN ORDINANCE ANNEXING CERTAIN TERRITORY

WHEREAS, the territory herein described below is contiguous to the Champaign-Urbana Mass Transit District, and is wholly within the corporate limits of the City of Urbana, Illinois, and is not a part of another local mass transit district, and is not classified as farmland for assessment purposes pursuant to the Revenue Act of 1939; and

WHEREAS, the Board of Trustees held a public hearing on the 18th day of March, 2025 at 4:00 p.m. at First Baptist Church, 3311 South Philo Road, Urbana, Illinois, to consider the annexation of the territory described herein below; and

WHEREAS, the Board of Trustees caused to be published a Notice of Public Hearing in a newspaper of general circulation in Champaign County, Illinois, which said Notice was published on the 10th day of February, 2025, the 25th day of February, 2025, and the 7th day of March, 2025 in the Champaign-Urbana News-Gazette, all of which is more fully set forth in the Certificate of Publication attached hereto as "Attachment 1".

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE CHAMPAIGN-URBANA MASS TRANSIT DISTRICT OF URBANA, ILLINOIS AS FOLLOWS:
